though the first trial resulted in a hung jury, the case was tried again. the jury returned guilty verdicts on all seven counts of indecent assault and battery on a child on or about december 4, 1998. the evidence was sufficient to warrant the conviction. the defendant does not dispute that there was sufficient evidence that he committed the acts of which the victim testified in this trial. he argues only that there was insufficient evidence of force, the requirement of the second-degree offense of indecent assault and battery on a child. he claims that there was only one instance of pinching her buttocks, and it was evidence that the victim willingly submitted to his touching. since the touching was not accompanied by an additional act, such as force, or force coupled with repeated or persistent touching, the touch was not forcible. see leblanc v. commonwealth, 2 mass. app. ct. 381, 384 (1974). there was evidence that the defendant pushed the victim away during the course of the abuse and restrained her, and no other force was used. there was also evidence that the defendant placed the victim in a bear hug on more than one occasion to restrain her. that evidence was sufficient to warrant the verdict. the defendant again contends that the victim should have been found to be sexually experienced and an adult. he argues that the victim had knowledge of the sexual relationship between a mother and her daughter and was sexually experienced based

on that knowledge. as detailed above, there was sufficient evidence that the victim was a victim of child sexual abuse. the victim's assertion that the defendant abused her for the purpose of having sex with her was supported by the forensic evidence, which suggested sexual activity. the evidence of the familial relationship between the victim and her mother is relevant to suggest that she understood the relationship between a parent and a child, as well as the frequency of the type of sexual contact that was taking place between the defendant and the victim. the jury were not required to accept the defendant's argument that sexual knowledge generally has no bearing on whether a victim is a child or an adult. they were entitled to make the fact that the victim was a child inarticulate, as by a young mother explaining to her daughter the kind of touching the defendant had been engaging in with her, the fact relevant to their assessment of the nature of the victim's relationship to her mother.
